Update on Glasgow Children's Holiday Food Programme

1 Background

- 1.1 The council has provided funding since 2018/19 for a holiday food programme in the city's 23 council wards. The programme makes a hot meal and snack available to Glasgow's nursery, primary and secondary pupils aged 0-18 years during school holiday periods.
- 1.2 The focus of the programme is for the council to work with third sector organisations who were already delivering holiday projects to support the council's aim to tackle holiday hunger. Third sector organisations can apply for funds to help them upscale, expand provision and offer more places to children during holiday periods.
- 1.3 The 2020/21 programme was launched in December 2019 with an online application process and was widely publicised by stakeholders. Projects were approved at the City Administration Committee on 27 February 2020.
- 1.4 This report provides a brief update on the 2020 summer holiday programme in **Appendix 1** to this report.

2 Governance

- 2.1 Impact Funding Partners (formerly Voluntary Action Fund) was initially contracted via the Glasgow Health and Social Care Partnership to manage a Wellbeing for Longer in Glasgow Fund. This contractual arrangement was used to incorporate delivery of the children's holiday food programme.
- 2.2 From 2020/21, all elements of the programme including promotion, applications development, assessment, management and monitoring sit with the council Grants & Initiatives Team.
- 2.3 Recommendations for funding are made to the City Administration Committee at the beginning of each calendar year.

3 Next Steps

- 3.1 The 2021/2022 Programme closed for applications on 23 October 2020. It is anticipated that the recommendations will be submitted to the City Administration Committee on 28 January 2021.
- 3.2 It remains important for the council through the provision of food to enhance the delivery of services which are already taking place across communities. The programme is intended to complement existing activities and for the majority of council funds to go towards provision of food.
