Private Hire Car	Overprovision Policy	In terms of sections 10 (3A) and (3C) of the Civic Government (Scotland) Act 1982 ("the 1982 Act"), the Licensing Authority is satisfied that, having regard to the number of private hire cars operating in the city of Glasgow and the demand for private hire car services in that locality, there is no overprovision of private hire car services until the number of private hire car licences reaches 3450.
		In terms of section 10 (3B) of the 1982 Act, the Licensing Authority has determined that the whole of the City of Glasgow is the appropriate locality for the purposes of said section 10 (3A).
		The Licensing Authority is satisfied that having regard to the findings of an independent report by Local Transport Projects Ltd dated April 2023 and submissions from a representative of Local Transport Projects Ltd at a meeting of the Licensing and Regulatory Committee on 26th April 2023, that for the purposes of sections 10 (3A) (3B) and (3C) of the 1982 Act, there will be no overprovision of private hire car services in the city of Glasgow until such time as the number of private hire car licences reaches 3450. When the number of private hire car licences reaches 3450 there will be an overprovision of private hire car services in city of Glasgow, and as such at that time there will be a rebuttable presumption against the grant of further private hire car licences. This will be known as "the Private Hire Car Licence Overprovision Policy".

### Appendix A

- (1) The Licence Holder shall adhere to all conditions detailed in reports by the Executive Director of Neighbourhoods, Regeneration and Sustainability (Building Control) and (Environmental Health).
- (2) The Licence Holder shall ensure that all relevant public liability insurance and necessary safety certificates are in place to cover the event and all activities taking place on the premises throughout the period of the licence and that each such public liability insurance be for an indemnity of not less than £5,000,000.
- (3) The Licence Holder shall ensure that copies of all relevant public liability insurance and safety documentation are available at the premises during the period of the licence and are available for inspection by an authorised officer of the Licensing Authority on request and are thereafter retained for a period of at least 6 months after the expiry of the licence.
