#### CIVIC GOVERNMENT (SCOTLAND) ACT 1982 TAXI DRIVER'S LICENCE – SUSPENDED

Purpose of Report:
To advise Members of the circumstances leading to the immediate suspension of Mr Peter White's taxi driver's licence (TD16772).
Recommendations:
Members are asked to consider, in view of the background information and having given the licence holder an opportunity to be heard, whether to:-
(a) suspend Mr White's taxi driver's licence for the unexpired portion of its duration or such shorter period as you may determine and, if so, whether the suspension is with immediate effect; or
(b) revoke Mr White's taxi driver's licence.

#### 1 Background

- 1.1 Mr Peter White was granted the renewal of his taxi driver's licence by this Authority on 3 September 2023 for a period of three years with effect from 1 June 2023 and with an expiry date of 31 May 2026 subject to the requirement that he attends medical examinations during the month of September 2023, 2024 and 2025.
- 1.2 The Licensing Section received a report from People Asset Management regarding Mr White's fitness in terms of Group 2 standards, a copy of which will tabled at the meeting.
- 1.3 In view of the terms of this information and in terms of paragraph 12 of Schedule 1 to the Civic Government (Scotland) Act 1982, Mr White's taxi driver's licence was suspended on 7 November 2025 with immediate effect for a period of six weeks, since it was deemed that his continued taxi driving would be likely to cause a serious threat to public safety.
- 1.4 Members will be aware that following the immediate suspension of Mr White's licence, this Committee is required to consider whether it is necessary or appropriate to suspend or revoke the licence in terms of paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982.
