**CIVIC GOVERNMENT (SCOTLAND) ACT 1982
PRIVATE HIRE CAR LICENCE – SUSPENDED**

Purpose of Report:

To advise Members of the circumstances leading to the immediate suspension of Mr Rostam Samadi's private hire car licence (PV25919).

Recommendations:

Members are asked to consider, in view of the background information and having given the licence holder an opportunity to be heard, whether to:-

- (a) suspend Mr Samadi's private hire car licence for the unexpired portion of its duration or such shorter period as you may determine and, if so, whether the suspension is with immediate effect; or

1 Background

- 1.1 Mr Rostam Samadi was granted the renewal of his private hire car licence by this Authority on 6 December 2024 for a period of three years with effect from 1 July 2024 and with an expiry date of 30 June 2027.
- 1.2 The Licensing Section received a complaint from the Chief Constable, Police Scotland dated 12 June 2025 requesting that Mr Samadi's private hire car licence be suspended. A copy of the complaint will be tabled at the meeting.
- 1.3 In view of the terms of this information and in terms of paragraph 12 of Schedule 1 to the Civic Government (Scotland) Act 1982, Mr Samadi's private hire car licence was suspended on 13 June 2025 with immediate effect for a period of six weeks, since it was deemed that his continued operation of the private hire car would be likely to cause a serious threat to public safety.
- 1.4 Due to an administrative oversight, Mr Samadi's hearing for this Committee to consider whether to further suspend the licence, revoke the licence or take no action, within 6 weeks of the immediate suspension, did not take place. Mr Samadi's licence was subsequently re-suspended with immediate effect on 23 October 2025 when the oversight came to light within the Licensing Section.
- 1.5 Members will be aware that following the immediate suspension of Mr Samadi's licence, this Committee is required to consider whether it is necessary or appropriate to suspend or revoke the licence in terms of paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982.
