### FESTIVE LIGHTING PROGRAMME 2025/26

#### Purpose of Report:

The purpose of this report is:

- (1) to advise members of the central funding available and the pricing guidelines for the 2025/26 festive lighting programme.
- (2) remind members of the 24/25 festive lighting programme; and
- (3) to seek agreement on the 25/26 programme and, where necessary, the allocation of additional funding.

#### Recommendations:

The Area Partnership is asked to:

- (1) note the lighting arrangements and the central funding available for the 2025/26 programme;
- (2) approve the necessary funding for any additional costs over and above the central funding.

## Introduction

1. The Council took the decision to delegate funding for peripheral festive lighting to the Area Partnerships as part of the budget process for 20/21. A similar arrangement is proposed for the 2025/26 programme.
2. Each Area Partnership is awarded £3,600 central funding to meet the costs of erecting and maintaining festive lighting, usually at a single location.
3. Area Partnerships have the option to fund additional festive lighting locations.

## 24/25 Festive Lighting Programme

4. The festive lighting programme for the Ward delivered as part of the 24/25 programme is shown below.

## 25/26 Festive Lighting Programme

5. The prices reflect the new contract rates for this festive season. The Festive Lighting delivery programme was subject to a new procurement exercise for years 2024 to 2028. The standard pricing schedule for the 24/28 festive lighting programme is set out below

GCC has procured the Festive Lighting contract at reduced costs from previous years. Area Partnerships will benefit from the fixed competitive contract rates over the next four years. An annual inflationary increase has been included in the above rates to provide a consistency over the contract period.

- The Area Partnership is invited to identify the locations where a switch on event is proposed to be held for either a Xmas or natural tree. Column mounted features will come on at the same time as the streetlights on the day of installation.
- If the total cost of the delivering the festive lighting programme selected by the Area Partnership exceeds the £3,600 central funding, then the balance of the funding will require to be met by the Area Partnership from other funds.

9. All new festive requests will be subject to NRS Street Lighting approval for electrical supply

## **Recommendations**

10. The Area Partnership is asked to:

- (1) note the lighting arrangements and the central funding available for the 2025/26 programme;
- (2) approve the necessary funding for any additional costs over and above the central funding.

Note:

Request received for Festive Lighting in Cranhill area of the ward is not achievable at this moment due to street lighting infrastructure not being suitable and approvals needed. NRS Festive Team will liaise with NRS Street Lighting colleagues in 2026 to discuss options in the area.

Various other sites in Carntyne area also inspected by NRS for Festive Lights, which is achievable, however as per online meeting 30<sup>th</sup> October with Councillor Blench, it was agreed to inspect Gartcraig Road junction with Ruchazie Road for 8no of Column Mounted Features.

At AP meeting on 5<sup>th</sup> November, request received for column mounted features at Carntyne Road and Carntyne Square. Table at Point 6 has been updated to reflect the change in costs for the AP to approve.
