Minutes of meeting held on 8th November 2024, Hybrid meeting.

Minutes of previous meeting approved.

1 The minutes of 30th August 2024 were submitted and approved.

Glasgow Community Planning Partnership Governance Framework - Membership update noted.

2 There was submitted and noted a report by the Director of Legal and Administration regarding the membership of this Partnership, indicating that there had been no changes since the previous meeting.

Community Planning Partnership – Governance Framework - Register of Interests noted.

3 There was submitted and noted a report by the Director of Legal and Administration advising the Partnership of the requirements in relation to the Community Planning Partnership Governance Framework regarding the registration and declaration of members' interests and detailing those interests which had been declared by members of the Partnership, as detailed in the report.

Police Scotland ward update noted.

4 There was heard a report by Inspector James McFarlane, Police Scotland, advising the Partnership that

- (1) 76 new probation officers had been recruited to work in the Glasgow area;
- (2) Operation Moonbeam https://www.scotland.police.uk/what-s-happening/news/2024/october/operation-moonbeam-2024/ had been launched again this year for Bonfire night. This was a multi agency project to reduce firework offences;
- (3) Newlands Division had received 2,211 calls with an increase in both crime and traffic offences, for the period 30th August 2024 to 8th November 2024; and
- (4) requested that a detailed report for the Eastwood Area be submitted to the next area partnership meeting.

After consideration, the Partnership noted the report and thanked Inspector James McFarlane for the update.

Ward update noted- Request to Scottish Fire and Rescue Service.

- There was submitted and noted a report by the Scottish Fire and Rescue Service (SFRS) regarding the current issues, incidents and work being carried out in the ward for Quarter 2, from 1st June to 30th September 2024, advising the Partnership
- (1) that the Service had attended 950 incidents in the South area, these being 309 fires, 176 special service incidents and 465 false alarms;
- (2) there had been an increase in the number of fires attended during Q2 2024/25, however the figure remained below the 5 year figure; and
- (3) the changes to Unwanted Fire Alarm Signals (UFAS), response from 1st July 2023 had seen a significant reduction in the number of false alarm incidents attended by operational crews.

After consideration, the Partnership requested that SFRS provide information from the Risk Assessment for Hillpark Flats at Pentland Park for discussion at the next meeting of this Partnership.

Area Budget 2024/25 – Applications for funding dealt with etc – Declaration of interest.

With reference to the minutes of the Council's City Administration Committee of 21st March 2024, when the committee approved the 2024/25 Area Budget allocations, there was submitted a report by the Head of Policy and Corporate Governance, advising

- of the current position in relation to the Area Partnership's budget for 2024/25;
- that the Newlands/Auldburn Area Partnership's Budget allocation for 2024/25 was £66,248.48 and that to date had committed a total of £39,797.80 (60.1%) to various projects in the area, including £1,940.00 under the scheme of delegated functions, leaving a balance of £26,450.68 (39.9%); and
- (3) of the applications for funding from the Area Budget for 2024/25.

After consideration, the Partnership noted

- (a) the position regarding the Area Budget allocation for 2024/25; and
- (b) the applications dealt with under delegated functions, as detailed in the report; and
- (c) dealt with applications for funding as follows, the grant awards being subject to the conditions detailed in the report:

Health and Social Care Partnership – Adult Health and Wellbeing Survey 2022/23 - South Glasgow update noted.

- 7 There was submitted and noted a report by Siobhan Boyle, Chief Officer, Glasgow City Health and Social Care Partnership (GCHSCP), regarding an update on NHS Greater Glasgow and Clyde, Adult Health and Wellbeing Survey 2022/23, and the South locality findings, advising that
- (1) the sample size was 1,678 residents from the South area;

- (2) the survey content included financial wellbeing, social health, social capital, health behaviours and health and fitness;
- (3) 18% of people lived alone and 41% of people aged 75+ lived alone;
- (4) 69% had a positive view of the adequacy of their household income;
- (5) 1 in 5 felt isolated from family and friends and 79% felt they belonged to their local area;
- (6) 73% valued local friendships and 85% had a positive view of social support;
- (7) 26% were current smokers and 8% of non-smokers were exposed to smoke at home or someone else's home;
- (8) 67% felt safe walking alone in their area, even after dark;
- (9) 23% belonged to clubs/associations/clubs; and
- (10) 17% had used e-cigarettes in the last year.

Neighbourhood Infrastructure Fund update noted - Request to Executive Director of Neighbourhoods, Regeneration and Sustainability.

8 With reference to the minutes of 30th August 2024, there was submitted a report by the Executive Director of Neighbourhoods, Regeneration and Sustainability (NRS), regarding the Newlands/Auldburn Neighbourhood Infrastructure Fund, advising of the progress in relation to the process to support the Fund including a summary of commitments to date, as detailed in Appendix 1 to the report.

After consideration, the Partnership

- (1) noted the report; and
- (2) requested that the Executive Director NRS
 - (a) provide a range of options for works at Hillpark play area,
 Mansewood Park play area and Thornliebank Road play area
 (opposite Eastwood Nursery) indicating that Eastwood Nursery
 be involved in any discussions relating to the Thornliebank play
 area:
 - (b) provide costs to resurface sections of
 - (i) Burnfield Road between Nethercairn Road to Mansewood Road area down to Bell and Bane Printers;

- (ii) Monreith Road (between Langside Drive to Friarton Road), ensuring that road lining was replaced timeously after any resurfacing, particularly around schools and nursery areas; and
- (iii) provide a timeline and costings to repair the football pitch at the rear of Merrylea Primary School play area; and

(3) agreed that

- (a) £9,000 underspend from works at Ashtree Park be allocated to the Hillpark Play area; and
- (b) Eastwood Nursery be invited to attend a meeting yet to be arranged to discuss NIF ideas, e.g play park, CCTV, railings, and gate locks, etc.

Community Council proposals – NIF allocation by Community Councils – Proposals noted.

9 There was heard a verbal report by Councillor Ferguson regarding NIF allocation proposals for each Community Council within the Ward, advising of various proposals for consideration, as detailed in the attached appendix.

After consideration, the Partnership

- (1) noted the proposals for NIF allocation for each Community Council in the Ward, as detailed in the appendix; and
- (2) agreed
 - (a) to use the middle formula for funding allocations, as detailed in the appendix; and
 - (b) that any further proposals from Community Councils should be submitted through the Chair of this Partnership for consideration.
