CIVIC GOVERNMENT (SCOTLAND) ACT 1982 TAXI DRIVER'S LICENCE – SUSPENDED

Purpose of Report:

To advise Members of the circumstances leading to the immediate suspension of Mr Steven Fulton's taxi driver's licence (TD16182).

1 Background

- 1.1 Mr Steven Fulton was granted the grant of his taxi driver's licence by this Authority on 18 November 2022 for a period of three years with effect from 1 February 2022 and with an expiry date of 31 January 2025.
- 1.2 The Licensing Section received a complaint from the Chief Constable, Police Scotland dated 21 November 2024 requesting that Mr Fulton's taxi driver's licence be suspended. A copy of the complaint will be tabled at the meeting.
- 1.3 In view of the terms of this information and in terms of paragraph 12 of Schedule 1 to the Civic Government (Scotland) Act 1982, Mr Fulton's taxi driver's licence was suspended on 21 November 2024 with immediate effect for a period of six weeks, since it was deemed that his continued taxi driving would be likely to cause a serious threat to public safety.
- 1.4 Members will be aware that following the immediate suspension of Mr Fulton's licence, this Committee is required to consider whether it is necessary or appropriate to suspend or revoke the licence in terms of paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982.
