CIVIC GOVERNMENT (SCOTLAND) ACT 1982 PRIVATE HIRE CAR DRIVER'S LICENCE – SUSPENDED

Purpose of Report:	
To advise Members of the circumstances leading to the immediate suspension of Mr Muhammad Azhar's private hire car driver's licence (PD29897).

1 Background

- 1.1 Mr Muhammad Azhar was granted the renewal of his private hire car driver's licence by this Authority on 4 September 2023 for a period of three years with effect from 1 March 2023 and with an expiry date of 28 February 2026 subject to the requirement that he undergoes medical examinations during the month of October 2023, 2024 and 2025.
- 1.2 The Licensing Section received a report from People Asset Management dated 29 January 2025 regarding Mr Azhar's fitness in terms of Group 2 standards, a copy of which will tabled at the meeting.
- 1.3 In view of the terms of this information and in terms of paragraph 12 of Schedule 1 to the Civic Government (Scotland) Act 1982, Mr Azhar's private hire car driver's licence was suspended on 30 January 2025 with immediate effect for a period of six weeks, since it was deemed that his continued private hire car driving would be likely to cause a serious threat to public safety.
- 1.4 Members will be aware that following the immediate suspension of Mr Azhar's licence, this Committee is required to consider whether it is necessary or appropriate to suspend or revoke the licence in terms of paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982.
