**CIVIC GOVERNMENT (SCOTLAND) ACT 1982  
PRIVATE HIRE CAR DRIVER'S LICENCE – SUSPENDED**

**Purpose of Report:**

To advise Members of the circumstances leading to the immediate suspension of Mr Asad Aziz's private hire car driver's licence (PD30513).

## **1 Background**

- 1.1 Mr Asad Aziz was granted the renewal of his private hire car driver's licence by this Authority on 3 September 2023 for a period of three years with effect from 1 August 2023 and with an expiry date of 31 July 2026.
- 1.2 The Licensing Section received a complaint from Police Scotland on 13 November 2025 regarding Mr Aziz's suitability to continue to hold a private hire car driver's licence. A copy of the complaint will be tabled at the meeting.
- 1.3 In view of the terms of this information and in terms of paragraph 12 of Schedule 1 to the Civic Government (Scotland) Act 1982, Mr Aziz's private hire car driver's licence was suspended on 14 November 2025 with immediate effect for a period of six weeks, since it was deemed that his continued private hire car driving would be likely to cause a serious threat to public safety.
- 1.4 The Police complaint was scheduled to be considered by this Committee at its meeting on 3 December 2025 however was omitted from that agenda due to an administrative oversight. Mr Aziz's licence was therefore further suspended with immediate effect on 29 December 2025.
- 1.5 Members will be aware that following the immediate suspension of Mr Aziz's licence, this Committee is required to consider whether it is necessary or appropriate to suspend or revoke the licence in terms of paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982.
