**CIVIC GOVERNMENT (SCOTLAND) ACT 1982  
PRIVATE HIRE CAR DRIVER'S LICENCE – SUSPENDED**

**Purpose of Report:**

To advise Members of the circumstances leading to the immediate suspension of Mr Jasbir Singh Athwal's private hire car driver's licence (PD29821).

## **1 Background**

- 1.1 Mr Jasbir Singh Athwal was granted the grant of his private hire car driver's licence by this Authority on 15 June 2023 for a period of three years with effect from 15 June 2023 and with an expiry date of 31 March 2026 subject to the requirement that he attends medical examinations as required.
- 1.2 The Licensing Section received information from Police Scotland that there has been a change to Athwal's medical condition.
- 1.3 In view of the terms of this information and in terms of paragraph 12 of Schedule 1 to the Civic Government (Scotland) Act 1982, Mr Athwal's private hire car driver's licence was suspended on 11 December 2025 with immediate effect for a period of six weeks, since it was deemed that his continued private hire car driving would be likely to cause a serious threat to public safety.
- 1.4 Members will be aware that following the immediate suspension of Mr Athwal's licence, this Committee is required to consider whether it is necessary or appropriate to suspend or revoke the licence in terms of paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982.
