**CIVIC GOVERNMENT (SCOTLAND) ACT 1982
PRIVATE HIRE CAR DRIVER'S LICENCE – SUSPENDED**

Purpose of Report:

To advise Members of the circumstances leading to the immediate suspension of Mr Mohammed Gobara's private hire car driver's licence (PD33838).

1 Background

- 1.1 Mr Mohammed Gobara was granted the grant of his private hire car driver's licence by this Authority on 20 February 2025 for a period of three years with effect from 20 February 2025 and with an expiry date of 30 September 2027.
- 1.2 The Licensing Section received a complaint from Police Scotland on 7 November 2025 regarding Mr Gobara's suitability to continue to hold a private hire car driver's licence.
- 1.3 In view of the terms of this information and in terms of paragraph 12 of Schedule 1 to the Civic Government (Scotland) Act 1982, Mr Gobara's private hire car driver's licence was suspended on 7 November 2025 with immediate effect for a period of six weeks, since it was deemed that his continued private hire car driving would be likely to cause a serious threat to public safety.
- 1.4 The Police complaint was scheduled to be considered by this Committee at its meeting on 26 November 2025 however was omitted from that agenda due to an administrative oversight. Mr Gobara's licence was therefore further suspended with immediate effect on 19 December 2025.
- 1.5 Members will be aware that following the immediate suspension of Mr Gobara's licence, this Committee is required to consider whether it is necessary or appropriate to suspend or revoke the licence in terms of paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982.
