**CIVIC GOVERNMENT (SCOTLAND) ACT 1982
TAXI DRIVER'S LICENCE – SUSPENDED**

Purpose of Report:

To advise Members of the circumstances leading to the immediate suspension of Mr Asad Aziz's taxi driver's licence (TD17092).

Recommendations:

Members are asked to consider, in view of the background information and having given the licence holder an opportunity to be heard, whether to:-

- (a) suspend Mr Aziz's taxi driver's licence for the unexpired portion of its duration or such shorter period as you may determine and, if so, whether the suspension is with immediate effect; or
- (b) revoke Mr Aziz's taxi driver's licence.

1 Background

- 1.1 Mr Asad Aziz was granted the grant of his taxi driver's licence by this Authority on 14 December 2023 for a period of three years with effect from 14 December 2023 and with an expiry date of 30 November 2026.
- 1.2 The Licensing Section received a complaint from Police Scotland on 13 November 2025 regarding Mr Aziz's suitability to continue to hold a taxi driver's licence. A copy of the complaint will be tabled at the meeting.
- 1.3 In view of the terms of this information and in terms of paragraph 12 of Schedule 1 to the Civic Government (Scotland) Act 1982, Mr Aziz's taxi driver's licence was suspended on 14 November 2025 with immediate effect for a period of six weeks, since it was deemed that his continued taxi driving would be likely to cause a serious threat to public safety.
- 1.4 The Police complaint was scheduled to be considered by this Committee at its meeting on 3 December 2025 however was omitted from that agenda due to an administrative oversight. Mr Aziz's licence was therefore further suspended with immediate effect on 29 December 2025.
- 1.5 Members will be aware that following the immediate suspension of Mr Aziz's licence, this Committee is required to consider whether it is necessary or appropriate to suspend or revoke the licence in terms of paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982.
