**CIVIC GOVERNMENT (SCOTLAND) ACT 1982
PRIVATE HIRE CAR DRIVER'S LICENCE – SUSPENDED**

Purpose of Report:

To advise Members of the circumstances leading to the immediate suspension of Mr James Johnston's private hire car driver's licence (PD33673).

Recommendations:

- (a) suspend Mr Johnston's private hire car driver's licence for the unexpired portion of its duration or such shorter period as you may determine and, if so, whether the suspension is with immediate effect; or

1 Background

- 1.1 Mr James Johnston was granted the grant of his private hire car driver's licence by this Authority on 21 May 2025 for a period of three years with effect from 1 December 2024 and with an expiry date of 30 November 2027.
- 1.2 The Licensing Section received a report from People Asset Management on 21 November 2025 regarding Mr Johnston's fitness in terms of Group 2 standards, a copy of which will be tabled at the meeting.
- 1.3 In view of the terms of this information and in terms of paragraph 12 of Schedule 1 to the Civic Government (Scotland) Act 1982, Mr Johnston's private hire car driver's licence was suspended on 21 November 2025 with immediate effect for a period of six weeks, since it was deemed that his continued private hire car driving would be likely to cause a serious threat to public safety.
- 1.4 As there was no meeting of this Committee during the Council recess, Mr Johnston's licence was further suspended with immediate effect on 29 December 2025.
- 1.5 Members will be aware that following the immediate suspension of Mr Johnston's licence, this Committee is required to consider whether it is necessary or appropriate to suspend or revoke the licence in terms of paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982.
