**CIVIC GOVERNMENT (SCOTLAND) ACT 1982  
TAXI DRIVER'S LICENCE – SUSPENDED**

**Purpose of Report:**

To advise Members of the circumstances leading to the immediate suspension of Mr Michael McSorley's taxi driver's licence (TD16643).

## **1 Background**

- 1.1 Mr Michael McSorley was granted the grant of his taxi driver's licence by this Authority on 7 November 2023 for a period of three years with effect from 7 November 2023 and with an expiry date of 31 October 2026 subject to the requirement that he attends medical examinations during the month of October 2024, 2025 and 2026.
- 1.2 The Licensing Section received a report from People Asset Management on 19 November 2025 regarding Mr McSorley's fitness in terms of Group 2 standards, a copy of which will be tabled at the meeting.
- 1.3 In view of the terms of this information and in terms of paragraph 12 of Schedule 1 to the Civic Government (Scotland) Act 1982, Mr McSorley's taxi driver's licence was suspended on 20 November 2025 with immediate effect for a period of six weeks, since it was deemed that his continued taxi driving would be likely to cause a serious threat to public safety.
- 1.4 As there was no meeting of this Committee during the Council recess, Mr McSorley's licence was further suspended with immediate effect on 29 December 2025.
- 1.5 Members will be aware that following the immediate suspension of Mr McSorley's licence, this Committee is required to consider whether it is necessary or appropriate to suspend or revoke the licence in terms of paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982.
