**CIVIC GOVERNMENT (SCOTLAND) ACT 1982
PRIVATE HIRE CAR DRIVER'S LICENCE – SUSPENDED**

Purpose of Report:

To advise Members of the circumstances leading to the immediate suspension of Mr Khurram Qadri's private hire car driver's licence (PD30262).

Recommendations:

Members are asked to consider, in view of the background information and having given the licence holder an opportunity to be heard, whether to:-

- (a) suspend Mr Qadri's private hire car driver's licence for the unexpired portion of its duration or such shorter period as you may determine and, if so, whether the suspension is with immediate effect; or
- (b) revoke Mr Qadri's private hire car driver's licence.

1 Background

- 1.1 Mr Khurram Qadri was granted the grant of his private hire car driver's licence by this Authority on 15 August 2023 for a period of three years with effect from 1 June 2023 and with an expiry date of 31 May 2026.
- 1.2 The Licensing Section received a complaint from the Chief Constable, Police Scotland dated 13 May 2025 requesting that Mr Qadri's private hire car driver's licence be suspended. A copy of the complaint will be tabled at the meeting.
- 1.3 In view of the terms of this information and in terms of paragraph 12 of Schedule 1 to the Civic Government (Scotland) Act 1982, Mr Qadri's private hire car driver's licence was suspended on 6 June 2025 with immediate effect for a period of six weeks, since it was deemed that his continued private hire car driving would be likely to cause a serious threat to public safety.
- 1.4 As there were no meetings of this Committee at the end of this six week period due to the summer recess, Mr Qadri's private hire car driver's licence was further suspended with immediate effect on 18 July 2025.
- 1.5 Members will be aware that following the immediate suspension of Mr Qadri's licence, this Committee is required to consider whether it is necessary or appropriate to suspend or revoke the licence in terms of paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982.
