**CIVIC GOVERNMENT (SCOTLAND) ACT 1982
PRIVATE HIRE CAR DRIVER'S LICENCE – SUSPENDED**

Purpose of Report:

To advise Members of the circumstances leading to the immediate suspension of Mr Satinder Singh's private hire car driver's licence (PD32689).

Recommendations:

1 Background

- 1.1 Mr Satinder Singh was granted the grant of his private hire car driver's licence by this Authority on 20 June 2024 for a period of three years with effect from 1 June 2024 and with an expiry date of 31 May 2027.
- 1.2 The Licensing Section received a complaint from the Chief Constable, Police Scotland dated 30 July 2025 requesting that Mr Singh's private hire car driver's licence be suspended. A copy of the complaint will be tabled at the meeting.
- 1.3 In view of the terms of this information and in terms of paragraph 12 of Schedule 1 to the Civic Government (Scotland) Act 1982, Mr Singh's private hire car driver's licence was suspended on 30 July 2025 with immediate effect for a period of six weeks, since it was deemed that his continued private hire car driving would be likely to cause a serious threat to public safety.
- 1.4 Members will be aware that following the immediate suspension of Mr Singh's licence, this Committee is required to consider whether it is necessary or appropriate to suspend or revoke the licence in terms of paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982.
