CIVIC GOVERNMENT (SCOTLAND) ACT 1982 PRIVATE HIRE CAR LICENCE – SUSPENDED

Purpose of Report:
To advise Members of the circumstances leading to the immediate suspension of Mr Khurram Qadri's private hire car licence (PV25770).

1 Background

- 1.1 Mr Khurram Qadri was granted the grant of his private hire car licence by this Authority on 9 October 2024 for a period of three years with effect from 1 May 2024 and with an expiry date of 30 April 2027.
- 1.2 The Licensing Section received a complaint from the Chief Constable, Police Scotland dated 13 May 2025 requesting that Mr Qadri's private hire car licence be suspended. A copy of the complaint will be tabled at the meeting.
- 1.3 In view of the terms of this information and in terms of paragraph 12 of Schedule 1 to the Civic Government (Scotland) Act 1982, Mr Qadri's private hire car driver's was suspended on 6 June 2025 with immediate effect for a period of six weeks, since it was deemed that his continued operation of his private hire car would be likely to cause a serious threat to public safety.
- 1.4 As there were no meetings of this Committee at the end of this six week period due to the summer recess, Mr Qadri's private hire car licence was further suspended with immediate effect on 18 July 2025.
- 1.5 Members will be aware that following the immediate suspension of Mr Qadri's licence, this Committee is required to consider whether it is necessary or appropriate to suspend or revoke the licence in terms of paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982.
