**CIVIC GOVERNMENT (SCOTLAND) ACT 1982  
TAXI DRIVER'S LICENCE – SUSPENDED**

**Purpose of Report:**

To advise Members of the circumstances leading to the immediate suspension of Mr Simon O'Connor's taxi driver's licence (TD18171).

## 1 Background

- 1.1 Mr O'Connor holds a taxi driver's licence (expiry date 31 October 2028) with this Licensing Authority. The Licensing Section received a complaint from Police Scotland on 17 April 2026 regarding Mr O'Connor's suitability to continue to hold a taxi driver's licence. A copy of the complaint will be tabled at the meeting.
- 1.2 In view of the terms of this information and in terms of paragraph 12 of Schedule 1 to the Civic Government (Scotland) Act 1982, Mr O'Connor's taxi driver's licence was suspended on 17 April 2026 with immediate effect for a period of six weeks, since it was deemed that his continued taxi driving would be likely to cause a serious threat to public safety.
- 1.3 Members will be aware that following the immediate suspension of Mr O'Connor's licence, this Committee is required to consider whether it is necessary or appropriate to suspend or revoke the licence in terms of paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982.
