**CIVIC GOVERNMENT (SCOTLAND) ACT 1982
PRIVATE HIRE CAR DRIVER'S LICENCE – SUSPENDED**

Purpose of Report:

To advise Members of the circumstances leading to the immediate suspension of Mr Ansumana Sanneh's private hire car driver's licence (PD29895).

Recommendations:

1 Background

- 1.1 Mr Ansumana Sanneh was granted the renewal of his private hire car driver's licence by this Authority on 11 July 2023 for a period of three years with effect from 1 March 2023 and with an expiry date of 28 February 2025. A renewal application is currently being processed by the Licensing Section.
- 1.2 The Licensing Section received a complaint from Police Scotland on 2 March 2026 regarding Mr Sanneh's suitability to continue to hold a private hire car driver's licence. A copy of the complaint will be tabled at the meeting.
- 1.3 In view of the terms of this information and in terms of paragraph 12 of Schedule 1 to the Civic Government (Scotland) Act 1982, Mr Sanneh's private hire car driver's licence was suspended on 2 March 2026 with immediate effect for a period of six weeks, since it was deemed that his continued private hire car driving would be likely to cause a serious threat to public safety.
- 1.4 Members will be aware that following the immediate suspension of Mr Sanneh's licence, this Committee is required to consider whether it is necessary or appropriate to suspend or revoke the licence in terms of paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982.
