**CIVIC GOVERNMENT (SCOTLAND) ACT 1982
PRIVATE HIRE CAR DRIVER'S LICENCE – SUSPENDED**

Purpose of Report:

To advise Members of the circumstances leading to the immediate suspension of Mr Ghulam Rasul's private hire car driver's licence (PD29331).

1 Background

- 1.1 Mr Ghulam Rasul was granted the renewal of his private hire car driver's licence by this Authority on 3 July 2023 for a period of three years with effect from 1 October 2022 and with an expiry date of 30 September 2025 subject to the requirement that he attends medical examinations as required. A renewal application is currently being processed by the Licensing Section.
- 1.2 The Licensing Section received a report from People Asset Management advising that Mr Rasul failed to attend recent medical examinations.
- 1.3 In view of the terms of this information and in terms of paragraph 12 of Schedule 1 to the Civic Government (Scotland) Act 1982, Mr Rasul's private hire car driver's licence was suspended on 13 February 2026 with immediate effect for a period of six weeks, since it was deemed that his continued private hire car driving would be likely to cause a serious threat to public safety.
- 1.4 Members will be aware that following the immediate suspension of Mr Rasul's licence, this Committee is required to consider whether it is necessary or appropriate to suspend or revoke the licence in terms of paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982.
