**CIVIC GOVERNMENT (SCOTLAND) ACT 1982
TAXI DRIVER'S LICENCE – SUSPENDED**

Purpose of Report:

To advise Members of the circumstances leading to the immediate suspension of Mr John Palmieri's taxi driver's licence (TD17411).

Recommendations:

- (a) suspend Mr Palmieri's taxi driver's licence for the unexpired portion of its duration or such shorter period as you may determine and, if so, whether the suspension is with immediate effect; or
- (b) revoke Mr Palmieri's taxi driver's licence.

1 Background

- 1.1 Mr John Palmieri was granted the renewal of his taxi driver's licence by this Authority on 13 June 2024 for a period of three years with effect from 1 June 2024 and with an expiry date of 31 May 2027 subject to the requirement that he attends a medical examination during the month of November 2025.
- 1.2 The Licensing Section received information from Mr Palmieri regarding a change to his fitness in terms of Group 2 standards.
- 1.3 In view of the terms of this information and in terms of paragraph 12 of Schedule 1 to the Civic Government (Scotland) Act 1982, Mr Palmieri's taxi driver's licence was suspended on 13 February 2026 with immediate effect for a period of six weeks, since it was deemed that his continued taxi driving would be likely to cause a serious threat to public safety.
- 1.4 Members will be aware that following the immediate suspension of Mr Palmieri's licence, this Committee is required to consider whether it is necessary or appropriate to suspend or revoke the licence in terms of paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982.
