**CIVIC GOVERNMENT (SCOTLAND) ACT 1982
TAXI DRIVER'S LICENCE – SUSPENDED**

Purpose of Report:

To advise Members of the circumstances leading to the immediate suspension of Mr Alan Murphy's taxi driver's licence (TD17014).

Recommendations:

1 Background

- 1.1 Mr Alan Murphy was granted the renewal of his taxi driver's licence by this Authority on 22 January 2024 for a period of three years with effect from 1 October 2023 and with an expiry date of 30 September 2026 subject to the requirement that he attends medical examinations during the month of January 2025 and 2026.
- 1.2 The Licensing Section received a report from People Asset Management advising that Mr Murphy failed to attend recent medical examinations.
- 1.3 In view of the terms of this information and in terms of paragraph 12 of Schedule 1 to the Civic Government (Scotland) Act 1982, Mr Murphy's taxi driver's licence was suspended on 26 February 2026 with immediate effect for a period of six weeks, since it was deemed that his continued taxi driving would be likely to cause a serious threat to public safety.
- 1.4 Members will be aware that following the immediate suspension of Mr Murphy's licence, this Committee is required to consider whether it is necessary or appropriate to suspend or revoke the licence in terms of paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982.
