**CIVIC GOVERNMENT (SCOTLAND) ACT 1982  
TAXI DRIVER'S LICENCE – SUSPENDED**

**Purpose of Report:**

To advise Members of the circumstances leading to the immediate suspension of Mr Amjad Aftab's taxi driver's licence (TD16820).

## 1 Background

- 1.1 Mr Amjad Aftab was granted the grant of his taxi driver's licence by this Authority on 25 August 2023 for a period of three years with effect from 25 August 2023 and with an expiry date of 31 July 2026 subject to the requirement that he attends a medical examination during the month of November 2025.
- 1.2 The Licensing Section received information from Mr Aftab regarding a change to his fitness in terms of Group 2 standards.
- 1.3 In view of the terms of this information and in terms of paragraph 12 of Schedule 1 to the Civic Government (Scotland) Act 1982, Mr Aftab's taxi driver's licence was suspended on 26 February 2026 with immediate effect for a period of six weeks, since it was deemed that his continued taxi driving would be likely to cause a serious threat to public safety.
- 1.4 Members will be aware that following the immediate suspension of Mr Aftab's licence, this Committee is required to consider whether it is necessary or appropriate to suspend or revoke the licence in terms of paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982.
