**CIVIC GOVERNMENT (SCOTLAND) ACT 1982
TAXI DRIVER'S LICENCE – SUSPENDED**

Purpose of Report:

To advise Members of the circumstances leading to the immediate suspension of Mr Michael Flood's taxi driver's licence (TD18055).

Recommendations:

1 Background

- 1.1 Mr Michael Flood was granted the renewal of his taxi driver's licence by this Authority on 9 October 2025 for a period of three years with effect from 1 January 2026 and with an expiry date of 31 December 2028 subject to the requirement that he attends a medical examination during the month of November 2025, 2026, 2027 and 2028.
- 1.2 The Licensing Section received information from Mr Flood regarding a change to his fitness in terms of Group 2 standards.
- 1.3 In view of the terms of this information and in terms of paragraph 12 of Schedule 1 to the Civic Government (Scotland) Act 1982, Mr Flood's taxi driver's licence was suspended on 17 February 2026 with immediate effect for a period of six weeks, since it was deemed that his continued taxi driving would be likely to cause a serious threat to public safety.
- 1.4 Members will be aware that following the immediate suspension of Mr Flood's licence, this Committee is required to consider whether it is necessary or appropriate to suspend or revoke the licence in terms of paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982.
