**CIVIC GOVERNMENT (SCOTLAND) ACT 1982
PRIVATE HIRE CAR DRIVER'S LICENCE – SUSPENDED**

Purpose of Report:

To advise Members of the circumstances leading to the immediate suspension of Mr Michael Esho's private hire car driver's licence (PD31196).

Recommendations:

- (a) suspend Mr Esho's private hire car driver's licence for the unexpired portion of its duration or such shorter period as you may determine and, if so, whether the suspension is with immediate effect; or

1 Background

- 1.1 Mr Michael Esho was granted the grant of his private hire car driver's licence by this Authority on 6 December 2023 for a period of three years with effect from 6 December 2023 and with an expiry date of 30 November 2026 subject to the requirement that he attends medical examinations during the month of November 2024, 2025 and 2026.
- 1.2 The Licensing Section received a report from People Asset Management advising that Mr Esho failed to attend recent medical examinations.
- 1.3 In view of the terms of this information and in terms of paragraph 12 of Schedule 1 to the Civic Government (Scotland) Act 1982, Mr Esho's private hire car driver's licence was suspended on 20 March 2026 with immediate effect for a period of six weeks, since it was deemed that his continued private hire car driving would be likely to cause a serious threat to public safety.
- 1.4 Members will be aware that following the immediate suspension of Mr Esho's licence, this Committee is required to consider whether it is necessary or appropriate to suspend or revoke the licence in terms of paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982.
