AREA BUDGET 2025/26: APPLICATIONS FOR FUNDING

Purpose of Report:

To provide the Area Partnership with details of the current position of the 2025/26 Area Budget; inform members of applications considered under Delegated Functions; and make recommendations on further applications for funding.

Recommendations:

The Area Partnership is asked to:

- (1) note the budget position for 2025/26; and
- (2) note any applications considered under Delegated Functions.

Introduction.

1. This report provides details on the Area Partnership's budget position for 2025/26; any applications considered under Delegated Functions; and makes recommendations on further funding applications.

Background.

2. Glasgow City Council agreed its budget for 2025/26 on 13th February 2025 with the overall funding available for Area Partnerships maintained at 2024/25 levels. The City Administration Committee approved allocations to Area Partnership on 13th March 2025. The Maryhill Area Budget for 2025/26 is £66,444.00.
3. The Area Partnership committed £66,444.00 from the 2025/26 Area Budget to date, had been committed to date to various projects serving the area, leaving a balance of £0 yet to be allocated.

Ineligible Applications

4. The following application was ineligible for Area Partnership funding - **Scottish Pottery Museum Community Board – Did not meet Criteria requirements. Advice has been given for re-submission.**
5. Members are asked to note that, due to recent updates to the Area Budget criteria any Applications requesting funding from all 23 Area Partnerships are deemed ineligible. Please see extracts from eligibility criteria below
 - Applications that are made to more than one Area Partnership to consider will be limited to neighboring electoral wards and within the sectors of South, North West and North East Glasgow.
 - The Communities Team will reach out to the Applicant to offer support and guidance for any future Area Budget submissions.

Area Budget Returned Funds

6. At its meeting on the 12 September 2025 the partnership approved an award of £1,904 to Healy Arts to support the costs of providing free design workshops for adults.

Confirmation has since been received from the Applicant that the project will no longer proceed. Therefore, a total of £1,904 was returned to the 2025/26 Area Budget for re-investment.

Delegated Functions
