**CIVIC GOVERNMENT (SCOTLAND) ACT 1982
PRIVATE HIRE CAR DRIVER'S LICENCE – SUSPENDED**

Purpose of Report:

To advise Members of the circumstances leading to the immediate suspension of Mr Zulfqar Ahmed's private hire car driver's licence (PD34330).

1 Background

- 1.1 Mr Zulfqar Ahmed was granted the renewal of his private hire car driver's licence by this Authority on 12 January 2026 for a period of three years with effect from 1 May 2025 and with an expiry date of 30 April 2028 subject to the requirement that he attends medical examinations as required.
- 1.2 The Licensing Section received a report from People Asset Management regarding Mr Ahmed's fitness in terms of Group 2 standards, a copy of which will tabled at the meeting.
- 1.3 In view of the terms of this information and in terms of paragraph 12 of Schedule 1 to the Civic Government (Scotland) Act 1982, Mr Ahmed's private hire car driver's licence was suspended on 13 January 2026 with immediate effect for a period of six weeks, since it was deemed that his continued private hire car driving would be likely to cause a serious threat to public safety.
- 1.4 Members will be aware that following the immediate suspension of Mr Ahmed's licence, this Committee is required to consider whether it is necessary or appropriate to suspend or revoke the licence in terms of paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982.
