**CIVIC GOVERNMENT (SCOTLAND) ACT 1982
TAXI DRIVER'S LICENCE – SUSPENDED**

Purpose of Report:

To advise Members of the circumstances leading to the immediate suspension of Mr Munir Ahmed's taxi driver's licence (TD16892).

1 Background

- 1.1 Mr Munir Ahmed was granted the renewal of his taxi driver's licence by this Authority on 26 September 2023 for a period of three years with effect from 1 September 2023 and with an expiry date of 31 August 2026 subject to the requirement that he attends medical examinations subject to the requirement that he attends medical examinations during the month of January 2024, 2025 and 2026.
- 1.2 The Licensing Section received a report from People Asset Management on 12 January 2026 regarding Mr Ahmed's fitness in terms of Group 2 standards, a copy of which will tabled at the meeting.
- 1.3 In view of the terms of this information and in terms of paragraph 12 of Schedule 1 to the Civic Government (Scotland) Act 1982, Mr Ahmed's taxi driver's licence was suspended on 13 January 2026 with immediate effect for a period of six weeks, since it was deemed that his continued taxi driving would be likely to cause a serious threat to public safety.
- 1.4 Members will be aware that following the immediate suspension of Mr Ahmed's licence, this Committee is required to consider whether it is necessary or appropriate to suspend or revoke the licence in terms of paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982.
