**CIVIC GOVERNMENT (SCOTLAND) ACT 1982  
TAXI DRIVER'S LICENCE – SUSPENDED**

**Purpose of Report:**

To advise Members of the circumstances leading to the immediate suspension of Mr Joseph Fisher's taxi driver's licence (TD17934).

## **1      Background**

1.1 Mr Joseph Fisher was granted the renewal of his taxi driver's licence by this Authority on 6 June 2025 for a period of three years with effect from 1 April 2025 and with an expiry date of 31 March 2028 subject to the requirement that he attends medical examinations subject to the requirement that he attends medical examinations during the month of November 2025, 2026 and 2027.

1.2 The Licensing Section received a report from People Asset Management on 8 January 2026 regarding Mr Fisher's fitness in terms of Group 2 standards, a copy of which will be tabled at the meeting.

1.3 In view of the terms of this information and in terms of paragraph 12 of Schedule 1 to the Civic Government (Scotland) Act 1982, Mr Fisher's taxi driver's licence was suspended on 9 January 2026 with immediate effect for a period of six weeks, since it was deemed that his continued taxi driving would be likely to cause a serious threat to public safety.

1.4 Members will be aware that following the immediate suspension of Mr Fisher's licence, this Committee is required to consider whether it is necessary or appropriate to suspend or revoke the licence in terms of paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982.
