**CIVIC GOVERNMENT (SCOTLAND) ACT 1982
PRIVATE HIRE CAR DRIVER'S LICENCE – SUSPENDED**

Purpose of Report:

To advise Members of the circumstances leading to the immediate suspension of Mr Maqsood Ahmed's private hire car driver's licence (PD33813).

Recommendations:

Members are asked to consider, in view of the background information and having given the licence holder an opportunity to be heard, whether to:-

- (a) suspend Mr Ahmed's private hire car driver's licence for the unexpired portion of its duration or such shorter period as you may determine and, if so, whether the suspension is with immediate effect; or

1 Background

- 1.1 Mr Maqsood Ahmed was granted the renewal of his private hire car driver's licence by this Authority on 3 March 2025 for a period of three years with effect from 1 February 2025 and with an expiry date of 31 January 2028 subject to the requirement that he attends medical examinations during the month of January 2026, 2027 and 2028.
- 1.2 The Licensing Section received a report from People Asset Management on 22 January 2026 regarding Mr Ahmed's fitness in terms of Group 2 standards, a copy of which will be tabled at the meeting.
- 1.3 In view of the terms of this information and in terms of paragraph 12 of Schedule 1 to the Civic Government (Scotland) Act 1982, Mr Ahmed's private hire car driver's licence was suspended on 23 January 2026 with immediate effect for a period of six weeks, since it was deemed that his continued private hire car driving would be likely to cause a serious threat to public safety.
- 1.4 Members will be aware that following the immediate suspension of Mr Ahmed's licence, this Committee is required to consider whether it is necessary or appropriate to suspend or revoke the licence in terms of paragraph 11 of Schedule 1 to the Civic Government (Scotland) Act 1982.
