Pride in Place Programme: Springburn & Sighthill 2026/36:

Update on Progress

Purpose of Report:

To provide the Area Partnership with details on the current position of the 2026/36 Pride in Place Programme as it relates to the Springburn and Sighthill area and inform members of progress to date.

Introduction.

1. This report provides details on the Springburn and Sighthill Pride in Place budget position for 2026/2036; submissions to date, and governance arrangements in development.
2. Springburn & Sighthill has been selected to receive funding of up to £20 million over a ten-year period, enabling long-term investment in projects that will create thriving places, strengthen communities and empower local people to influence the future of their neighbourhoods.
3. A key feature of the Programme is the establishment of Neighbourhood Boards, placing local people at the centre of decisions around how funding is invested in their communities.
4. The Neighbourhood Board is responsible for preparing a Regeneration Plan that sets out a shared vision for Springburn/Sighthill over the next 10 years, alongside a more detailed Investment Plan covering the first four years of the programme. Developed in partnership with local communities and Glasgow City Council, the Regeneration Plan will identify a range of projects and interventions that will contribute to the programme's strategic objectives and support the long-term regeneration of Springburn & Sighthill.
5. The Neighbourhood Board Selection Process: All four relevant area partnerships in both Pride in Place areas were notified of the process to identify board Chairs.

When it came to board membership appointments in Springburn and Sighthill, letters were sent out by the MP's office to 7,000 households in the area, informing them about the PIP programme, and asking for expressions of interest in joining the board. That list was then collated and handed to the Chair.

The Chair, local MP and local authority were then involved in the selection process.

6. Guidance states that all places in the programme should move towards community-led delivery models by the end of year three of the programme. This pathway will vary in different places – a Neighbourhood Board could for example, transition into a community interest company, community benefit society or charity, or an existing community organisation could act as an anchor organisation and take on delivery responsibility. This may also lead to a change in the accountable body.

General governance arrangements are currently being developed with partners in GCC's NRS department and in conjunction with the Council's

Internal Audit Department to mirror the Assurance Framework developed to support the City Region investment.

This will provide a robust framework and guidance around formal processes for funding bids.
