## CITY DEVELOPMENT PLAN: SPATIAL SUPPLEMENTARY GUIDANCE INNER EAST STRATEGIC DEVELOPMENT FRAMEWORK (SDF)

#### **Purpose of Report:**

To advise members of the intention to submit the Inner East Strategic Development Framework (SDF) to Scottish Ministers prior to adoption as Supplementary Guidance to the City Development Plan.



#### 1 Background

- 1.1 A final draft of the Inner East Strategic Development Framework (SDF) was presented to the Economy, Housing, Transport and Regeneration City Policy Committee on 18 April 2023. Members were advised of the intention to adopt the SDF as Supplementary Guidance to the City Development Plan and of the next steps in this process.
- 1.2 After consideration, the Committee noted:
  - (a) the final draft of the Inner East Glasgow Strategic Development Framework; and;
  - (b) the intention to seek approval from the City Administration Committee, and to notify the Scottish Government, prior to the adoption of the Inner East Glasgow Strategic Development Framework as Supplementary Guidance to the City Development Plan.


#### 2 Glasgow City Development Plan

- 2.1 The Glasgow City Development Plan (the Plan) was adopted in March 2017 and informs all planning and land use decisions in Glasgow. The Plan provides the spatial strategy for development and regeneration across the city and seeks to deliver the key aims of:
  - A healthy, high-quality place;
  - A compact city form that supports sustainable development.
- 2.2 The Plan is supported by two overarching policies: CDP1 The Placemaking Principle and CDP2 Sustainable Spatial Strategy. One of the key elements of CDP2 is the identification of spatial priority areas across the city where additional guidance is required. This comprises six Strategic Development Framework (SDF) areas and three Local Development Framework (LDF) areas as shown in the diagram below.



#### 3 Strategic Development Frameworks

- 3.1 Strategic Development Frameworks (SDFs) represent areas of significant change and opportunity across the city. They provide an overarching framework for future planning and focus on strategic priorities rather than detailed policy issues or outputs. The SDFs set out area-specific principles, that will help in the determination of major planning applications, and include Action Programmes to support the delivery of key proposals. SDFs have been/are being prepared for the following areas:
  - River Clyde Development Corridor (adopted 2020)
  - Govan-Partick (adopted 2020)
  - City Centre (adopted 2021)
  - North Glasgow (adopted 2023)
  - Inner East (presented for approval)
  - Greater Easterhouse (in preparation)
- 3.2 Local Development Frameworks (LDFs) also address areas that face significant challenges and are deemed to require an additional layer of planning intervention. LDFs seek to provide an overarching framework and key principles for development, but at a more local level, and contain Action Programmes that identify opportunities to deliver change. The LDF areas are:
  - South Central
  - Drumchapel
  - Pollok.
- 3.3 The diagram below shows the scale of Supplementary Guidance within the City Development plan:



#### 4 Strategic Development Framework Consultation Process

- 4.1 Prior to adoption, the Council is required to carry out public consultation on each SDF. Details of the consultation and the final version of the SDF is submitted to the Scottish Ministers to ensure the process meets statutory requirements. The Ministers will assess the relationship between the Supplementary Guidance and the City Development Plan and will consider how the Council has responded to public comments in the final version of the document.
- 4.2 The Inner East SDF was published on the Council's Consultation Hub between 25 June 2021 and 6 September 2021. In response to the consultation, a number of organisations and individual members of the public submitted written responses in the format of an email or completed survey. A total of 470 respondents made comments on the draft SDF, with the breakdown as follows:

• By email: 16 respondents

• By survey: 454 respondents

• Total comments received: over 2000

4.3 Following consultation, the comments were collated and have informed the production of the final version of the SDF. In addition, the documented findings of a range of community-led planning events have helped shape the document. The <u>Table of Responses</u> sets out where changes have been made.

#### 5 Inner East SDF

5.1 The Inner East SDF reflects the policies of the City Development Plan, establishes principles to guide development and supports the delivery of initiatives such as the Collegelands Calton Barras City Deal programme, Liveable Neighbourhoods and the Transformational Regeneration Area (TRA) at Gallowgate. It sets out the following vision and key outcomes for this area of the city:

#### Vision:

The Inner East will become a city district made up of distinct, well connected, vibrant and climate resilient neighbourhoods. This will be achieved through community engagement to ensure an inclusive, community-led design that represents local needs.

#### **Key Outcomes:**

- A VIBRANT INNER EAST The Inner East will be a vibrant place and a key asset to the City's economy.
- A SUSTAINABLE INNER EAST -The Inner East will be an engaged urban area able to support a diversity of facilities and services.

- A CONNECTED INNER EAST The Inner East will be better connected with a focus on active travel and public transport.
- A GREEN & RESILIENT INNER EAST The Inner East will have accessible multifunctional blue/green networks.

#### 6 Next Steps

- 6.1 Following the City Administration Committee, the final draft of the Inner East SDF, together with details of the consultation process and responses to representations, will be sent to the Scottish Ministers for consideration.
- 6.2 Unless Scottish Ministers direct otherwise, it is recommended that the Inner East SDF is adopted as Supplementary Guidance to the City Development Plan.

#### 7 Policy and Resource Implications

#### **Resource Implications:**

Financial: The SDFs and LDFs do not have any

immediate financial implications, although future capital projects are likely to emerge through the ongoing implementation of the Action Programmes. It is envisaged that any costs associated with the consultation process and production of the documents will be met

from within existing budgets.

Legal: There are no immediate legal implications

linked to the SDF and LDF production process.

Personnel: Staff from within NRS Planning Services will be

responsible for the production of the SDFs and

LDFs. Input from other services may be required going forward as detailed actions

emerge.

Procurement: Future procurement requirements where GCC

is the lead agency will be carried out in line with current procedures relating to sustainable

procurement and Article 19.
