#### **UK GOVERNMENT FUNDS – LEVELLING UP FUND**

#### **Purpose of Report:**

To provide an update on the UK Levelling Up Funding call round one, an overview of the process for round two and confirm bids for submission.

#### 1. INTRODUCTION

- 1.1 On 3 March 2021, as part of the UK Budget process, the UK Government launched three new UK wide funds, using the powers conferred on it through Sections 50 and 51 of the UK Internal Market Act 2020.
- 1.2 The three funds are the UK Shared Prosperity Fund, the UK Levelling Up Fund (LUF) and the UK Community Ownership Fund. These funds are intended to contribute to the UK Government's "levelling up" agenda.
- 1.3 This report provides an update on the UK Levelling Up Funding call round one, an overview of the process for round two and confirm proposed bids for submission.

#### 2. THE UK LEVELLING UP FUND

- 2.1 As noted in the UK Government Funding report that was presented to City Administration Committee (CAC) on 17 June 2021 (<a href="https://www.glasgow.gov.uk/councillorsandcommittees/viewDoc.asp?c=P62AFQDNDXNTUT2UDN">https://www.glasgow.gov.uk/councillorsandcommittees/viewDoc.asp?c=P62AFQDNDXNTUT2UDN</a>), bids for the Levelling Up Fund can be submitted by any local authority in Scotland, with the number of bids being dependent on the number of Westminster constituencies in each area.
- 2.3 Under the original terms of the Levelling Up Fund, Glasgow City Council could submit up to 7 bids (one per constituency), with a maximum value of £20M per application. There is also provision for the Council to submit one large scale transportation bid (with a value of between £20M and £50M).
- 2.4 The priority themes for the LUF are infrastructure projects under the following headings:
  - Smaller transport projects that make a genuine difference to local areas;
  - Town centre / high street / city centre regeneration; and
  - Support for maintaining and expanding the UK's world-leading portfolio of cultural and heritage assets.

#### 3. FUNDING CALL ROUND ONE

3.1 City Administration Committee approved the submission of the Pollok Country Park Stables and Courtyard project on 17 June 2021 and approved the acceptance of the £13.05m funding from the UK Government LUF on the 27 January 2022

3.2 The project has now commenced and is subject to a Memorandum of Understanding (MOU) with UK Government and reports through the council's Capital Programme Board.

#### 4.0 FUNDING CALL ROUND TWO

- 4.1 On the 23 March 2022, the UK Government published their prospectus providing guidance on round two of the fund (<a href="https://www.gov.uk/government/publications/levelling-up-fund-round-2-prospectus">https://www.gov.uk/government/publications/levelling-up-fund-round-2-prospectus</a>).
- 4.2 Themes remain broadly similar covering transport, regeneration and cultural investments. In addition, two constituency bids of up to £50 million (across the UK) will be funded under the culture and heritage investment theme.
- 4.3 The prospectus confirms the submission deadline for bids as 12 noon on 6 July 2022. Local Authorities are encouraged to bid in this round as UK government intend to evaluate the success of the first round, by Spring 2023, before committing to the timing or format of a third round.
- 4.4 In order for the Council to be able to meet the second funding call deadline GCC NRS officers have continued to review projects on the approved Expression of Interest (EoI) list between January and March 2022 against the following key criteria:
  - Readiness for submission;
  - Eligibility strategic fit and fit with levelling up themes and missions;
  - Deliverability: Business Case / Feasibility; Design; Planning status;
     Community Engagement; Approvals; and Construction timescales
- 4.5 From this exercise and discussions with key stakeholders the following projects noted in the Expression of Interest list from June 2021 have withdrawn from the process at the request of the applicant(s).
  - University of Glasgow MedTech Business & Research Hub -CWIC Campus
  - University of Glasgow Church Street Innovation Zone
  - University of Strathclyde City Centre GCID Technology & Innovation (TIC) Zone
  - GCC Glasgow Park Power Phase 1
- 4.6 Given the format and timing of round three is not confirmed, the number of bids have been maximised to cover all constituencies and categories. Officer's recommendations to Committee are therefore provided at **Appendix One**, noting:
  - Any unsuccessful bids will be notified in writing, following Committee approval with an offer to continue dialogue to identify potential other sources for funding.

- In line with the UK Government's technical guidance, a briefing was offered to all Glasgow MPs and MSPs and took place on 10 June 2022.
- 4.7 Further guidance on the application and assessment of bids to the Levelling Up Fund should be noted as follows:
  - LUF is a competitive funding stream, and as such, there is no guarantee that funding applications will be successful.
  - The application process is guided by HM Treasury's Green Book 5case model. This is a significant process which relies on specialised economic assessment and has been most recently used by Glasgow City Council for the City Deal programme.
  - Bids and constituent projects should secure the support of and be developed after consultation with relevant local stakeholders and partners and local MPs.

#### 5.0 FINANCE

- 5.1 Committee is asked to note that the LUF bids could attract up to a total £220m of LUF funding with each constituency bid expected to claim the full £20m available.
- The exception to this are the Cultural and Transport bids and indicative costs have been noted in Appendix One, for these projects.
- 5.3 Bids will require at least ten percent match funding which could be funded by GCC and/ or external sources.
- 5.4 There is a requirement that the Council (as the applicant body) will commit to underwrite any potential cost over-runs.
- 5.5 A further report will be presented to City Administration Committee to advise of any successful bids and seek approval to accept the funding.
