1 Introduction

- 1.1 This report comes to the City Administration Committee following a report on Trees and Woodland presented to the Environment Sustainability and Carbon Reduction City Policy Committee on <u>15 March 2022</u>.
- 1.2 This report described how trees and woodlands play vital roles in urban settings. While offering a home to wildlife and spaces for human recreation, they provide insurance against flooding, manage carbon emissions, control water flow and air quality, regulate temperature and energy usage, create jobs and provide multiple health benefits.
- 1.3 The report listed the key actions that were currently underway including:
 - Development work on Forest and Woodland Strategy
 - TreesAl
 - · Every tree tells a story; and
 - Cities4forests
- 1.4 The report noted that an invite had been extended to Glasgow to become a member of the Cities4forests network and that this membership offer would provide access to \$70,000 USD to help launch a partner forest programme in Glasgow.
- 1.5 The committee are asked to support the offer from Cities4forests to take part in their Partner Forest Programme and receive \$70k support funding.

2 Cities4forests

- 2.1 Leading from discussions at COP26, the Council has been asked to become a member of the Cities4forests network. This links to the objectives of the Trees and Woodland Strategy and extends Glasgow's global reach and commitment.
- 2.2 Cities4forests is a network of more than 75 global cities committed to supporting the world's forests on behalf of climate, biodiversity and social impacts. The Cities4forests team works directly with member city council representatives to help identify and shape effective projects and policies that meet member city goals.
- 2.3 With funding from Laudes Foundation, Cities4forests is launching seven Partner Forests in 2021 / 2022. Seven European cities will have access to \$70,000 USD each to source tropical hardwood from exemplary community forest conservation enterprises, to be used in prominent city infrastructure. Projects will showcase the community enterprise protecting the forest and the conservation benefits of using sustainably-sourced wood. These high-visibility exchanges will promote consumer awareness, forest stewardship, and urban policies that exhibit leadership on climate and biodiversity. Glasgow can help sequester millions of tons of carbon through partnerships with forest communities who are successfully conserving tropical forests, an activity which is a major step towards restoring the earth's carbon balance. These local-to-

local partnerships can demonstrate the power of "thinking globally, and acting locally".

- 2.4 The Partner Forests Program has the following outcomes:
 - Exciting programs for city residents, private sector and government;
 - Opportunities for forest communities to expand business and conservation work;
 - Connecting youth on both sides of the partnership, to each other and to opportunities for learning and livelihoods;
 - Awareness of tropical forests by city residents, and government;
 - Innovate financial models and business partnerships;
 - Global culture that protects and restores forests.

to-date.
