2 There was submitted a report by the Executive Director of Corporate Services detailing an application by Alan Bauld (PD08377) for the grant of a private hire car driver's licence for a 1 year period.

After consideration, Councillor Frank Docherty, seconded by Bailie Greene, moved that the application be granted with dispensation from condition 23 and that a warning be issued to the applicant regarding his future conduct.

Bailie Morrison, seconded by Councillor Millar, moved as an amendment that the application be granted with dispensation from condition 23 and that a severe warning be issued to the applicant regarding his future conduct.

On a vote being taken by a show of hands, 2 members voted for the amendment and 6 for the motion, which was accordingly declared to be carried.

3 There was submitted a report by the Executive Director of Corporate Services detailing an application by Thomas Craig (PD08408) for the grant of a private hire car driver's licence for a 1 year period.

After consideration, Bailie Greene, seconded by Councillor Black, moved that the application be granted and that a warning be issued to the applicant regarding his future conduct.

On a vote being taken by a show of hands, 4 members voted for the amendment and 4 for the motion. There being an equality of votes, the Chair gave his casting vote in favour of the motion, which was accordingly declared to be carried.

On a vote being taken by a show of hands, 3 members voted for the amendment and 5 for the motion, which was accordingly declared to be carried.
